LOOKS LIKE "HARMONY" IS GOING AWAY!

On Wednesday, August 8, the Highland City Council met to vote on whether to rescind (un-approve) the project approvals it had granted in the past, because of Judge Alvarez' decision on the CEQA (environmental) issues in the project. The staff had recommended the vote and the Council voted to repeal the land use entitlements, and invalidate two ordinances which were subject to the Referendum scheduled for November, effectively cancelling the need for the Referendum.

Several speakers had submitted comments, asking to speak. None was in favor of the project, although some had differing ideas as to how to deal with the land after the project was cancelled. Among the speakers were Bruce Bailey, an engineer who reminded the Council of the Lockheed contamination so close by, and Steve Rogers, who stated that the tract map would have to be recorded in order to implement the changes.

Dr. Frantz (sp?) suggested using it as a mitigation land bank, where developers could purchase acreage from that area in order to comply with the requirement to designate open land when developing other open land into tracts. [Ed.'s note: as we reported before, some of the land designated for projects located here is in *Kern County* – think Bakersfield!] He further stated that federal and state officials are in agreement with the idea, whereby Orange County – who owns the land – could recoup the full amount of their investment.

The City Council had already moved and seconded and they did not amend to include that option.

Another speaker was Anthony Serrano, who provided a history of the project before LAFCO and suggested the zoning be the same as it was in March 2000.
