# DID WE GET REDLANDS' ATTENTION ON AUGUST 24?

Another protest of Redlands' excessive and extortionate water meter costs and other fees, as well as annexations, took place on August 24, in front of Tom's Burgers, the store on Mentone Boulevard whose owners, Mr. and Mrs. Perry Koutzakis, have been trying to open for at least nine years.

They also own and operate the Tom's Burgers at 1280 Alabama, corner of Lugonia, in Redlands.

"It went well; we had a turnout of over 40, some even from Redlands protesting Redlands. We went from 9 to noon  $\bigcirc$ ," said Rich Orbaker, Mentone rancher and organizer of this and the previous protest. Also, a "newspaper reporter and photographer from the [Redlands Daily] facts were there for at least two hours," he continued.

"Four separate families stopped by and told us about Redlands stopping them from either moving into homes in Mentone due to water meter charges of \$85,000.00. All four were invited to be my guests at the next MACA meeting to tell their stories," he concluded.

MACA meets at 6:30 p.m. on the second Tuesday of the month at Diamond Jim's Saloon, in the back of the Mill Creek Cattle Company, 1874 Mentone Boulevard.

Orbaker is MACA's Vice President; its President is Gabe DeLaRosa and its Secretary is Angie DeLaRosa. For newcomers, parking is in front, on the side, in back and continues around the adjacent home, as well as on the street. MM
